

## TERMS & CONDITIONS OF SALES/ENTRY: INDULGE (“EVENT”)

**YOUR TICKET PURCHASE AND/OR ENTERING THIS EVENT CONSTITUTES YOUR ACCEPTANCE OF ALL THE TERMS AND CONDITIONS LISTED BELOW:**

1. Entry to the site is at your own risk. **THE LAUNCESTON FESTIVALE COMMITTEE INC (THE COMMITTEE)** its employees and agents are not responsible for any loss, injury or damage, howsoever caused.
  2. **NO REFUNDS** will be made in any case-this includes the cancellation of any promoted act or event due to circumstances beyond the control of **THE COMMITTEE**. The only exception to this will be that refunds will be provided should the Event be cancelled as a result of a Public Health Declaration that causes the cancellation of the event in its entirety.
  3. **THE COMMITTEE** and its agents reserves the right to refuse admission and to remove persons from the venue for any reason including behavior likely to cause damage, nuisance or annoyance or for failure to comply with the reasonable requests of **THE COMMITTEE** or its representatives staffing the Event.
  4. No alcohol, glass, fireworks, sparklers or similar articles, weapons or illegal substances of any type are to be brought onto the site – any found will be confiscated or may result in refused entry or removal from the Event
  5. **THE COMMITTEE**, its employees and agents are not responsible for any loss of property at the Event. Any items left at the Event will be held by Security on site and if not claimed will be surrendered to the Launceston Police Station on the first Tuesday post the Event.
  6. **THE COMMITTEE** and its security personnel may conduct bag or person searches or wandering and you agree to submit to such searches.
  7. No animals will be admitted to the Event (assistance & guide dogs exempt).
  8. No unauthorised trading is permitted within the site or within 10 meters of any Entrance to the Event.
  9. Pass outs will be issued in the form of a wristband for each patron which must not be tampered with. Failure to comply will result in refusal to re enter the Event. Pass outs will not be available for the last hour of each Event session. Entry is not permitted after this time and re-entry after these times is permitted only with previously issued pass outs.
  10. **THE COMMITTEE** and/or its employees or contractors of may record the Event. Your attendance at the Event shall constitute your approval for inclusion within the photography, filming and/or audio recording and you give your approval/permission for **THE COMMITTEE** to make full use of the photographs, recordings and/or the footage taken without any recourse to you. Unauthorized photography/filming/ sound recording is prohibited you agree to indemnify **THE COMMITTEE** for any claim of breach of copyright or any other damages should you breach this condition of entry.
  11. In the interests of public safety, **THE COMMITTEE** and its agents reserves the right to request you to leave the venue at any time for safety reasons or immediately after the Event
  12. **IN CASE OF EMERGENCY:** Please follow all directives of security personnel and staff
  13. **WARNING:** Please note that you will be exposed to loud music at the Event and to Occasional Coarse language that may offend. Do not enter the Event if this is not acceptable to you
  14. **NO MOSHING OR CROWD SURFING.**
  15. The Event is smoke free. Smoking is prohibited within the event or within 10 meters of any entrance to the Event.
  16. **THE COMMITTEE** notes that produce served at the event may contain, or have come into contact with wheat, seafoods, eggs, nuts, milk or other allergens. Due to these circumstances, **THE COMMITTEE**, its employees and servants are unable to guarantee that any menu item can be completely free of allergens.
  17. Directions made by **THE COMMITTEE**, its employees and its agents according to Public Health Guidelines must be followed. Patrons who refuse to follow such directions will be removed from the Event.
